### **Enhancements and Changes in Functionality:**

With the release of 2019.1.4-Rel.1, Development has made enhancements to the iOS and Android applications. The Image application now allows users to add Employee Images, Employee Signatures and Work Center Images. The Data Collection applications now include Work Queue functionality and the ability to view specific types of documents attached to a Job. The applications now have unique and user-friendly icon designs for easy identification. The Touchscreen application has been renamed to Data Collection.

Development corrected an issue where order processing attempted to update the Quote Status field on a Quote Line Item that did not exist in the database. The Order can now be processed.	190129361619

A code change was made so when a shipping address was marked as Default in Shop, that address would sync to QuickBooks Online. A code change was made and now if the user enters a Job Number that does not exist, the following message generates: Complete - Nothing to process! If the Job Number was found and Job Requirements have updated the user receives the following message: Update Complete - Refresh Job Req Completed!	190206363480
Tables	Error when running an Advanced Search	An error was reported when performing an Advanced Search. It was determined the default Sort By was being added to the end of the query for the Advanced Search. This caused the error to occur because the user has the option to choose their own sorting in the Advanced Search. Development has removed the default Sort By on Advanced Searches because users have the ability to choose the desired sorting.	190205363290
Tables	Editing Customer generates error	The customer reported an error is generated when attempting to edit a particular Customer table. Development optimized a portion of the code which reads and generates the Customer Table. The Customer can now be edited as expected.	190211364626
